# SIRIM LEAD AUDITOR COURSE ISO/IEC 17065:2012

#### **Duration: 5 Days**



## **PROGRAMME OVERVIEW**

This programme is designed specifically to help auditors/ assessors (internal and external) of a certification body offering product certification scheme to provide assurance that a product conforms to specified requirements in standards. Under this scheme, which is based on the ISO Scheme (guideline of requirements ISO/IEC 17067:2013), an applicant will be awarded a license to use the Certification Mark on their product upon compliance with the requirements of the specified standard. The license also demonstrates that the factory has a proper quality control system to ensure consistency and continuous compliance with the Product Certification requirement. The course includes detailed overview of all the elements and requirements of ISO/IEC 17065:2012, documentation needs in accordance with ISO/IEC 17065, steps for ISO 17065 accreditation, audit process and techniques. This 5 days course enables the certification body auditors to conduct proper auditing exercises using the right tools and methods in accordance with the ISO 19011:2018, Guideline for management system auditing.

- Understand the principles, methodologies, techniques and tools of assessment, and apply this acquired knowledge in the conduct of assessments
- Identify the management requirements of the primary accreditation criteria and apply these requirements to the assessment of management system in Certification Bodies (CBs)
- Identify the general technical requirements of the primary accreditation criteria documents and apply these requirements to the assessment of CBs the technical competence of within their area of expertise
- Plan, organize and conduct assessments of CBs against these requirements and in accordance with the procedures of the accreditation body
